Criteria:

Submission:

1. Applicant should submit application with personal essays to college Registrar.
2. Tuition Assistance Application.
3. Complete the FAFSA (put in Corban University or desired future University). Turn a completed FAFSA Estimated Family Contribution or Forward your FAFSA Confirmation Page E-Mail.

2 Essays:

- The first essay should be at least 1 page in length and include the following: brief background, what degree goal, what you will do with that degree once it's received, community outreach performed within the last 5 years, church membership, ministry involvement, your interests, what makes you a good recipient.
- ☐ The second personal essay should describe how Jesus Christ became personal to you, how someone becomes a Christian, and what it means to be a Christian. Please use scripture references in your response.

Deadline: Ask Registrar when the current scholarship deadlines are.

Selection: Selection of the recipient will be made by the Gather 4 Him Scholarship Committee.

Amount: The amount varies, depending on which scholarship you receive.

Duration: Per semester. A scholarship application must be submitted each new school year.

Recipient is to-

- ☐ Submit scholarship application, 2 essays attached (career goal and educational plan must be stated clearly in first essay), and Tuition Assistance Application
- ☐ Maintain a cumulative GPA of 2.5 each semester and follow scholarship attendance policy
- ☐ Submit grades no longer than 2 weeks after the end of each semester
